# Adams County Commissioners Candidate Questions John Rostvet

# Campaign statements often include "lower taxes," but, as costs increase, how do you prioritize realistic choices?

Priority must first be given to protecting and maintaining all that we are blessed to currently have. Emergency Services may not seem important, until you desperately need them. If Emergency Services are not prioritized, response times and the abilities of those responding will quickly suffer. As costs continue to rise, if elected, I would also prioritize proper maintenance of County resources and investments including equipment, buildings and wide range of infrastructure in order to maximize usage and life. With regard to investing toward the future of Adams County, if elected, I would first seek to be well informed, to listen and to then carefully consider the various needs and issues of those within District 2 in order to make informed decisions and prioritize that which best represents first, the needs and then the desire of residents throughout Adams County.

With 5 of the county's 7 districts being within or closely adjacent to Hastings, strong understanding and representation of the rural areas and communities of Adams County is essential if the Board of Commissioners is to effectively represent all of Adams County when prioritizing realistic choices that are fair and in the best interest of all residents and communities within Adams County. Therefore, if elected to represent District 2, I would prioritize the need for the Board to listen closely and equally consider our county's rural residents, businesses, industry and communities when prioritizing such choices.

## What is your vision for the growth and development of Hastings/Adams County businesses and industries?

Agriculture has and will continue to be the heartbeat and strength of Adams County. Businesses and industries which support agriculture thru production and sale of ag products along with industries which produce value added agricultural products are and will continue to be vital to Hastings/Adams County. That said, agriculture markets are and will likely continue to be volatile so my vision for healthy, sustainable growth and development of Hastings/Adams County must also include and encourage diversity, specifically a vision to seek out, encourage and support businesses and industries which are strong and economically stable in order to assure quality jobs and continued growth which is not predominantly or entirely dependent upon agriculture markets.

#### Are there any additional areas of potential cooperation between county government and other local government entities that you would support?

However, with that said, "yes" I would be quick to support any such cooperation if the primary goals and expected benefits of such cooperation were both realistic and clearly to better serve the residents, businesses, industry, and communities of Adams County. If elected as a County Commissioner of District 2, I would also look closely, question and voice opposition if necessary to any such cooperation which would clearly benefit only a select group or potion of Adams County residents, businesses industry or individual community in a manner that likely would not or could not realistically be supported elsewhere.
